Use appropriate personal protective equipment while working with the reagents provided. The Calibrators and Controls are formulated with a buffer base, Protein Based Buffer and Human serum. The human serums are tested by a CE/FDA licensed method and found to be non- reactive for HIV-1, HIV-2, Hepatitis B surface antigen and HCV. Because no test method can offer absolute assurance that these agents are absent, reagents should be handled at the Biosafety Level 2, as recommended for any potentially infectious human blood product.



Bovine products (BSA) have been derived from US origin and processed in USDA licensed facilities, and are free from known infections, however, it should be considered that no available test method can offer complete assurance of eliminating potential biohazardous risk. The antibodies are from monoclonal origin and are free from human or animal source.
